

**RESOLUTION NO. R25-19**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED ELECTRONIC WASTE WEEK AND SHRED DAY EVENT TO SERVE THE PUBLIC PURPOSE OF COMBATTING IDENTITY THEFT THROUGH THE PROPER DISPOSAL OF SENSITIVE ELECTRONIC AND PRINTED MATERIALS, WITH EXPENDITURES NOT TO EXCEED THREE THOUSAND DOLLARS (\$3,000.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, the proper disposal of sensitive electronic and printed materials serves to combat identity theft and protect citizens from financial and other peril; and

**WHEREAS**, community shredding and disposal events provide citizens who may not have the equipment and/or resources necessary to properly dispose of their own sensitive data to benefit from community resources; and

**WHEREAS**, an Electronic Waste Week and Shred Day Event shall be a City-sponsored event beginning Monday, August 4, 2025. The event will be held at the Public Works Building located at 2400 Olive Road in Trotwood, Ohio, from 9:00 a.m. to 3:00 p.m. daily thru Saturday, August 9, 2025. Bulk trash collection and shredding services will be available on Saturday, August 9, 2025 from 10:00 a.m. to 1:00 p.m. only.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council hereby determines that an Electronic Waste Week and Shred Day Event shall be a City-sponsored event intended to benefit the citizens of Trotwood by providing a safe and secure way for them to properly dispose of sensitive electronic and printed materials.

**SECTION II:** The Trotwood City Council hereby authorizes expenditures not to exceed Three Thousand Dollars (\$3,000.00) for shredding services, dumpster rental, signage, and other necessary supplies. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.
