

**RESOLUTION NO. R25-26**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
REAPPOINTING GAYLE JOHNSON TO THE CIVIL SERVICE  
COMMISSION FOR THE CITY OF TROTWOOD.**

**WHEREAS**, the City Charter established a Civil Service Commission consisting of five (5) qualified electors of the Municipality appointed by the majority vote of Council to serve a five-year term; and

**WHEREAS**, Council has an obligation to appoint members to such Commission, without compensation and subject to the obligations, powers, and duties as set forth in the City Charter and the Trotwood Codes of Ordinances; and

**WHEREAS**, Council must appoint a qualified elector of the City of Trotwood to fill an expired term and wishes to reappoint Gayle Johnson to serve on the Civil Service Commission for a term of five (5) years, commencing March 4, 2025.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** Gayle Johnson, a qualified elector of the City of Trotwood, is hereby reappointed to serve on the Civil Service Commission for a five-year term beginning March 4, 2025 and ending March 3, 2030.

**SECTION II:** Ms. Johnson shall be administered her Oath of Office at such time that is mutually convenient for said elector and the Mayor.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.


