

RESOLUTION NO. R25-38

A RESOLUTION BY THE TROTWOOD CITY COUNCIL ACKNOWLEDGING THAT THE CITY-COSPONSORED EVENT IN RECOGNITION OF MOTHER’S DAY HELD ON FRIDAY, MAY 9, 2025, SERVED THE VALID PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, AND THAT EXPENDITURES IN THE AMOUNT OF ONE HUNDRED FIFTY DOLLARS (\$150.00) WERE VALID PUBLIC EXPENDITURES.

WHEREAS, the Trotwood City Council recognizes the importance of reinforcing strong community relations by City-sponsored activities; and

WHEREAS, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, on May 9, 2025, at the Trotwood Community and Cultural Arts Center located at 4200 Lake Center Drive, the City of Trotwood cosponsored a Mother’s Day Brunch which provided an afternoon of celebration for the community, which served a valid public purpose in the City; and

WHEREAS, prior to the event, Council had not approved the expenditure of public funds for the event; and

WHEREAS, Council hereby recognizes that the expenditure of One Hundred Fifty Dollars (\$150.00) was a valid expenditure and would have been approved on request prior to the event.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The Trotwood City Council hereby determines that the Mother’s Day Brunch was a City-cosponsored event that helped to foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II: The Finance Department determined, after the event, that expenditures totaled One Hundred Fifty Dollars (\$150.00) and is requesting that City Council authorize the expense.

SECTION III:

The Trotwood City Council hereby agrees that it would have and now does authorize expenditures in the amount of One Hundred Fifty Dollars (\$150.00) for admission tickets.

SECTION IV:

This Resolution shall take effect and be in full force from and after the date of its passage.
