

**RESOLUTION NO. R25-62**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING ADDITIONAL EXPENDITURES NOT TO EXCEED TWO THOUSAND DOLLARS (\$2,000.00) FOR THE CITY-SPONSORED ANNUAL SMOKE, SIZZLE, AND SOUNDS FESTIVAL, WHICH SERVES THE PUBLIC PURPOSE OF BUILDING STRONG COMMUNITY RELATIONS.**

WHEREAS, on January 6, 2025, by Resolution No. R25-07, City Council approved the Annual Smoke, Sizzle, and Sounds Festival scheduled for Saturday, September 13, 2025 to be a City-sponsored event intended to serve the public purpose of building strong community relations, which serves a valid public purpose in the State of Ohio; and

WHEREAS, City Council also authorized expenditures for the approved City-sponsored Annual Smoke, Sizzle, and Sounds Festival not to exceed Ten Thousand Dollars (\$10,000.00) for contracted services, rental of portable restrooms, trash receptacles, other necessary supplies, and cash awards to the First, Second and Third Place winners of the BBQ Contest; and

WHEREAS, expenditures have increased as a result of rising costs for both supplies and entertainment, making it necessary to adjust the budget for this event by an additional Two Thousand Dollars (\$2,000.00), for a total budget not to exceed Twelve Thousand Dollars (\$12,000.00); and

WHEREAS, the Annual Smoke, Sizzle, and Sounds Festival will be a City-sponsored event to be held on Saturday, September 13, 2025 from noon to 7:00 p.m. at Madison Park, located at 301 South Broadway Street in Trotwood, Ohio.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

Due to an increase in expenditures as a result of rising costs for both supplies and entertainment, City Council hereby authorizes an additional Two Thousand Dollars (\$2,000.00), for a total budget not to exceed Twelve Thousand Dollars (\$12,000.00), for contracted services, rental of portable restrooms, trash receptacles, and other necessary supplies, for the City-Sponsored Annual Smoke, Sizzle, and Sounds Festival to be held on Saturday, September 13, 2025.


