

RESOLUTION NO. R26-09

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED COMMUNITY MARKET, WHICH SERVES A VALID PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED FIVE HUNDRED DOLLARS (\$500.00).

WHEREAS, City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

WHEREAS, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, the Trotwood Community Market shall be a City-sponsored event beginning Wednesday, July 1, 2026 at 5200 Salem Avenue in Trotwood, Ohio (former Salem Mall site). The Market will be open every Wednesday at 3:00 p.m. and operate through September 30, 2026, weather permitting. This event provides an opportunity for local farmers and other small businesses to sell their products, which helps promote strong community relations, thereby serving a valid public purpose in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council hereby determines that a Trotwood Community Market shall be a City-sponsored event that provides a forum for local farmers and other small businesses to sell their products, which helps promote strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II: City Council hereby authorizes expenditures not to exceed Five Hundred Dollars (\$500.00) to cover the cost of marketing materials (yard signs, banners, etc.) and other necessary supplies. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

SECTION III: This Resolution shall take effect and be in full force from and after the date of its passage.
