

**RESOLUTION NO. R26-11**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY-SPONSORED ANNUAL SMOKE, SIZZLE, AND SOUNDS FESTIVAL TO SERVE THE PUBLIC PURPOSE OF BUILDING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED TWELVE THOUSAND DOLLARS (\$12,000.00).**

**WHEREAS**, City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

**WHEREAS**, the Annual Smoke, Sizzle, and Sounds Festival shall be a City-sponsored event to be held on Saturday, September 12, 2026 from noon to 7:00 p.m. at Madison Park, located at 301 South Broadway Street in Trotwood, Ohio.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council hereby determines that the Annual Smoke, Sizzle, and Sounds Festival is a City-sponsored event intended to serve the public purpose of building strong community relations, which serves a valid public purpose in the State of Ohio.

**SECTION II:** City Council hereby authorizes expenditures not to exceed Twelve Thousand Dollars (\$12,000.00) for contracted services, rental of portable restrooms, trash receptacles, other necessary supplies, and to the First, Second, and Third Place winners of the BBQ Contest, cash awards in the following amounts:

First Place	\$500.00
Second Place	\$250.00
Third Place	\$175.00

City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.
