

RESOLUTION NO. R26-25

A RESOLUTION BY THE TROTWOOD CITY COUNCIL ACCEPTING THE BID OF JOHN R. JURGENSEN, CO. FOR PAVEMENT REPAIRS AND RESURFACING WORK TO BE COMPLETED ON THE FOLLOWING ROADWAYS: SOUTH WOLF CREEK PIKE (NOLAN ROAD TO NORTH SNYDER ROAD), WOLF ROAD (SALEM AVENUE TO TURNER ROAD), NATCHEZ AVENUE (MYRON AVENUE TO JASON AVENUE), OAKES ROAD (5271 OAKES ROAD TO SHILOH SPRINGS ROAD - 1 INCH SCRATCH AND MOSS CREEK BOULEVARD TO SHILOH SPRINGS ROAD - CHIP SEAL), NORTHFORD ROAD, WEYBRIDGE DRIVE, DUNN PLACE, AND SEYBOLD ROAD (SOUTH WOLF CREEK PIKE TO BRIDGE JOINT); AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE THE 2026 PAVING PROGRAM FOR AN AMOUNT NOT TO EXCEED \$948,491.23, WHICH IS THE CONTRACT AMOUNT OF \$862,264.75, PLUS A 10% CONTINGENCY AMOUNT OF \$86,226.48.

WHEREAS, the City is repairing and resurfacing various roadways in the City; and

WHEREAS, the City properly advertised the 2026 Paving Program project as required by law and the bid of the John R. Jurgensen, Co. (“Jurgensen”), was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Public Works Project Manager recommend that City Council authorize the City Manager to enter into an agreement with Jurgensen to complete the work necessary for the above-described pavement repair and resurfacing project for an amount not to exceed \$948,491.23, which is the contract price of \$862,264.75, plus a contingency amount equal to 10% of the total contact price, or \$86,226.48.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The City solicited bids for the 2026 Paving Program to include pavement repairs and resurfacing work to be completed on South Wolf Creek Pike (Nolan Road to North Snyder Road), Wolf Road (Salem Avenue to Turner Road), Natchez Avenue (Myron Avenue to Jason Avenue), Oakes Road (5271 Oakes Road to Shiloh Springs Road - 1 Inch Scratch and Moss Creek Boulevard to Shiloh Springs Road - Chip Seal), Northford Road, Weybridge Drive, Dunn Place, and Seybold Road (South Wolf Creek Pike to Bridge Joint).

SECTION II:

The bids were reviewed and the City Manager and Public Works Project Manager recommend that City Council accept the bid of John R. Jurgensen, Co. ("Jurgensen") for the above-described repair and resurfacing work.

SECTION III:

City Council finds that the bid of Jurgensen was the lowest and best bid submitted and, therefore, accepts the same.

SECTION IV:

City Council authorizes the City Manager to enter into an agreement with Jurgensen to complete the work necessary for the above-described repair and resurfacing project for an amount not to exceed \$948,491.23, which is the contract price of \$862,264.75, plus a contingency amount equal to 10% of the total contact price, or \$86,226.48.

SECTION V:

Funds have been appropriated in the Street Income Tax Fund (Fund 219) or are in the process of collection in an amount sufficient to pay the authorized contract amount.

SECTION VI:

This Resolution shall take effect and be in full force from and after the date of its passage.
