

**RESOLUTION NO. R26-28**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
AUTHORIZING THE CITY MANAGER TO ENTER INTO A  
FULL-SERVICE STREET LIGHTING AGREEMENT WITH  
MIAMI VALLEY LIGHTING, LLC.**

**WHEREAS**, the City of Trotwood (the “City”) previously entered into a ten-year Full-Service Street Lighting Agreement with Miami Valley Lighting, LLC (“MVLt”) effective January 1, 2016, Ordinance No. OR05-16, for the provision and maintenance of street lighting services with the City; and

**WHEREAS**, City Council, on June 2, 2025 via Ordinance No. OR08-25, agreed to participate in a consortium of municipalities to jointly negotiate the Street Lighting Agreement through the Miami Valley Communications Council (“MVCC”); and

**WHEREAS**, the current Street Lighting Agreement, as extended, is scheduled to expire on April 30, 2026; and

**WHEREAS**, MVCC and MVLt have successfully negotiated a seven-year Successor Street Lighting Agreement for the continued provision and maintenance of street lighting services within the City; and

**WHEREAS**, the City Manager recommends City Council authorize the City Manager to enter into an Agreement with MVLt for the continued maintenance of street lighting services within the City under the provisions of the successor agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council accepts the recommendation of the City Manager and hereby authorizes the City Manager to enter into seven-year Successor Street Lighting Agreement with Miami Valley Lighting for the purpose of providing street lighting services on public grounds and streets.

**SECTION II:** City Council authorizes the City Manager, or his designee, to take all actions necessary to carry out the intent of this legislation.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
