

RESOLUTION NO. R26-33

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO DECLARE CERTAIN OBSOLETE AND/OR SURPLUS POLICE DEPARTMENT VEHICLES AND EQUIPMENT AS NO LONGER NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING SAID VEHICLES AND EQUIPMENT TO BE SOLD TO LOCAL AUTO SALVAGE COMPANIES, AT PUBLIC AUCTION, AND/OR OTHERWISE DISPOSED OF.

WHEREAS, the Police Chief has determined that certain vehicles and equipment of the Trotwood Police Department can no longer be utilized because these vehicles and equipment are no longer safe and/or serviceable and the cost to restore these vehicles and equipment to a safe and/or serviceable condition exceeds the value of the property; and

WHEREAS, the City Manager agrees that certain vehicles and equipment belonging to the City are in non-functioning order, obsolete and/or surplus, and no longer needed for any public purpose; and

WHEREAS, the Police Chief has requested these obsolete and/or surplus items be sold to local auto salvage companies, at public auction, and/or otherwise disposed of; and

WHEREAS, the City Manager recommends that Council declare the items obsolete and/or surplus and authorize the items set forth in the attached Exhibit "A" to be sold to local salvage companies, at public auction, and/or otherwise disposed of.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: Trotwood City Council hereby finds that the property listed in Exhibit "A", which is attached hereto and incorporated herein by reference, is obsolete and/or surplus, and no longer needed for any public purpose.

SECTION II: The City Manager is hereby authorized to have the vehicles and equipment listed in the attached Exhibit "A" sold to local salvage companies, at public auction, and/or otherwise disposed of.
