

**RESOLUTION NO. R26-38****A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
AUTHORIZING THE CITY MANAGER TO ACCEPT STATE  
CAPITAL IMPROVEMENT PROGRAM FUNDS FROM THE  
OHIO PUBLIC WORKS COMMISSION FOR PHASE THREE OF  
THE EPPINGTON WATER MAIN REPLACEMENT PROJECT.**

**WHEREAS**, the City has determined it is necessary to replace aging water lines and several fire hydrants on portions of Eppington Drive through a series of four phases; and

**WHEREAS**, the City applied for and was awarded funding through the State Capital Improvement Program ("SCIP") from the Ohio Public Works Commission ("OPWC") in the amount of \$908,941.00, of which \$454,470.00 are grant funds and \$454,471.00 is an interest-free loan needed to complete phase three of this infrastructure project; and

**WHEREAS**, the City secured funding for the balance of the total project cost of \$983,941.00, or \$75,000.00, with funds previously awarded through Montgomery County's Community Development Block Grant ("CDBG") Program accepted by City Council on September 2, 2025, Resolution No. R25-59; and

**WHEREAS**, the Deputy City Manager and the Public Works Supervisor recommend that the Trotwood City Council authorize the City Manager to accept the SCIP grant funds and interest-free loan from the OPWC in order to complete phase three of the Eppington Water Main Replacement Project.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

City Council accepts the recommendation of the Deputy City Manager and Public Works Supervisor and hereby authorizes the City Manager to accept SCIP grant funds and an interest-free loan from the OPWC in the amount of \$908,941.00, \$454,470.00 in grant funds and an interest-free loan in the amount of \$454,471.00 to replace aging water lines and several fire hydrants on portions of Eppington Drive

**SECTION II:**

The City of Trotwood previously accepted grant funds in the amount of \$75,000.00 from Montgomery County's CDBG Program to fund the balance of the total project cost of \$983,941.00.

**SECTION III:**

This Resolution shall take effect and be in force from and after the date of its passage.
